REQUIREMENTS FOR ANIMAL ENTRY ARE SUBJECT TO CHANGE WITHOUT NOTICE. YOU MUST CONTACT THE STATE OF DESTINATION TO INSURE YOUR ANIMAL MEETS THEIR ENTRY REQUIREMENTS.

NOTE: Numerous Racetracks (and other facilities) throughout the Country have established Piroplasmosis Testing as a requirement for Entry. Our advice to horsemen shipping to tracks, training facilities and other venues is to check and insure their horses meet thevenue's defined criteria for entry.
